4. Review and adoption of minutes of the last meeting

5. Action point 1 from the last meeting: The handover report- review of activities of outgoing SDF Executive and the areas the incoming SDF Executive should be mindful of

Alieu SK Cham reviewed the activities carried out by the outgoing SDF Executive Committee. He highlighted the available funds as well as the following areas as being challenges that the incoming Executive Committee need to be mindful of going forward:
