4. Review and adoption of minutes of the last meeting

The minutes were reviewed and adopted

5. Report on action points from last meeting:

a) Alieu Cham to report on the outcome of his discussion with Ndemba Kebba

Alieu Cham reported that he had a conversation with Ndemba Kebba who told him that he had been confined to bed for the past 10 months following a stroke.

Decision: The Executive Committee will suggest to the members of SDF to cancel Ndemba Kebba's loan to SDF (D39 000) because of his poor health.

Action point 1: In order to continue to provide healthcare in Sika, SDF will try to find a replacement for Ndemba Kebba. Omar Janneh and Kabiro Janneh will check with Bintou Janneh Kumba and Pa Manneh respectively about that.

b) On strengthening the Executive Committee of SDF – the Social and Resource Mobilization Secretaries to report to the meeting on the outcome of their discussion

Lamin Sonko (Nani) reported that Satou Camara and Mariama Sawo-Camara had agreed to join the Executive Committee.

Action point 2: Omar Janneh will check with Lamin Famoro whether he would accept to join the Executive Committee.

Decision: A 4-member team comprising Alieu Cham, Omar Janneh, Bakary T Sonko and Saikou Lamin has been setup to look into areas that need to be strengthened and suggest suitable candidates to be co-opted to those areas.

d) On the registration of SDF as a charity in the UK

In order to facilitate the registration of SDF as a charity in the UK, the Executive Committee adopted the revised Constitution that Omar Janneh had sent to the Executive Committee members ahead of the meeting.
